Public Comments: There were no public comments.

Approval of May 13, 2025, Minutes: Jack moved to approve the minutes; Sibby seconded. Minutes were approved.

Unfinished Business

- 1. Oath of office for Debra and Andrea: Andrea will complete the oath of office before our next meeting.
- 2. Website design deadline: end of July. There are a few items that need fine tuning, but the website should be finished on time.
- 3. Report on water sample:
 - a. The sample sent to Johnson City has not been completed.
 - b. Sibby will take a sample to Austin for testing.
- 4. Approval of 2025-2026 budget
 - a. The budget was reviewed.
 - b. Sibby moved to approve the 2025-2026 budget, Andrea seconded, and the budget was approved.
- 5. Status of audit:
 - a. Mr. Davis presented the results of the audit.
 - b. We are in good standing in the fund balance.
- 6. Staff evaluations completed
- 7. Report on Pocket Meadow: Marilyn and Sibby reported.
 - a. There will be a barn structure in place of a traditional gazebo. This will provide classroom space as well as a viewing area.
 - b. The sign is being designed and constructed by Thaddeus Mallard.
 - c. Katie is actively looking for grants to develop/support the pocket meadow project.

New Business

- 1. Election of new officers: This item has been tabled until all oaths of office have been completed.
- 2. Determine library holidays for 2025-2026: The library will be closed on the following dates:

- 3. Notice from Comptroller's office re. taxes to be returned: Sibby moved to pay the invoice in full. Andrea seconded, and the motion was approved.
- 4. Review library policy on law enforcement requests and search warrants
 - a. Crystal has updated the policy based on ALA recommendations.
 - b. Andrea moved to approve the new policy. Sibby seconded, and the motion was approved.
- 5. Request to purchase conference camera (Owl Labs 360 Camera, \$1, 050)
 - a. Allows for hybrid programs using Zoom
 - b. Jack moved to approve the purchase. Andrea seconded, and the motion was approved.
- 6. Discussion re. possible retirement benefit for full-time staff: This discussion item has been tabled in order to complete further research.
- 7. Investment Report Pat Clewell Smith presented the status of the CD holdings.
- 8. Friends of the Library Report Rosalind Ellis: There was no report.
- 9. Blanco Library, Inc. Report Marilyn Melton
 - a. The Inc. board is investigating continuing the Doran Endowment.
 - b. The Inc. board would like to fine tune the responsibilities of repairs list.
 - c. There is a proposal to do the building inspection twice a year instead of once a year.
- 10. Budget and Financial Report: The report was reviewed.
- 11. Financial Report- Evann Ramsey
 - a. Asked that the May bills be paid. Andrea moved to pay the bills. Sibby seconded, and the motion was approved.
 - b. Evann asked to change the Amazon account to a business account with Crystal, Brian, and herself as users of the account. This would make it easier to monitor and report purchases. The board agreed.
